# 23MN14170 – Endangering the Welfare of a Child

On Thursday, April 20, 2023, at approximately 6:00 a.m., Jake Melman, a 22year-old, unmarried, male resident of Manalapan, who is employed as an umpire, was arrested and charged with possession of child sexual abuse material. The arrest was made as the result of an investigation conducted by Monmouth County Prosecutor's Office Internet Crimes Against Children Task Force. On that date, members of the task force executed a search warrant at the residence of Jake Melman after a lengthy child sexual abuse material investigation. The Internet Crimes Against Children Task Force consists of members of the Monmouth County Prosecutor's Office, the Manalapan Township Police Department, the Bradley Beach Police Department, the Tinton Falls Police Department, and the Highlands Boro Police Department. The investigation revealed that Jake Melman possessed, viewed, and downloaded items depicting child sexual abuse material. Mr. Melman was placed under arrest and subsequently transported to Manalapan Township Police Headquarters, where he was charged with third degree possession of child pornography (NJS 2C:24-4b(5)(b)(iii). He was remanded to Monmouth County Correctional Institution pending a court appearance.
