25MN25335 – Warrant Arrest

On Tuesday, July 22nd, 2025, at approximately 10:34 p.m. Patrolman Anthony Carcaldi responded to the Freehold Borough Police Department in reference to a warrant arrest. Patrols took custody of Samiyah Anderson-Neal, a 35-year-old, married female, employed resident of Freehold Borough New Jersey. Mrs. Anderson-Neal had an active warrant issued for her arrest issued out of the Manalapan Township Municipal Court for \$1,000.00.
