**25MN27043 – Fraud**

On August 5, 2025, at approximately 6:58 p.m., a 66-year-old Manalapan resident reported that an unknown actor attempted to purchase a Cricket phone from AT&T for \$44.65 using their credit card. No monetary loss had been reported. Patrolman Brandon Yeung handled the report.
